- 7. Advices the Research & Development department on all IP related matters, through Prior Art Searches, Freedom-to-Operate searches, Technology Tracking & Mapping, Technology Forecasting exercises
- 8. Advice on Research Publications, Journals, Media bulletins and technology exposures/demonstrations
- 9. Manages the Invention Disclosure Procedures and other Confidentiality clauses/Agreements and forms
- Liaise with the Business Specialist Office on Technology Commercial Viability assessments
- Supports ITC and law enforcement investigations/actions, in coordination with intellectual property & litigation counsel.
- 12. Drafts Patents, Utility Models, Design Rights applications and manage the overall NARDI IP Portfolio
- 13. Conducts regular IP-protected Technology demonstrations & exhibitions, and Match-making events
- 14. Conducts regular IP Awareness sessions for NARDI Staff and Stakeholders
- 15. Implements the Stakeholder Engagement Framework and other support company Policies.
- 16. Designs and implements the IP Commercialisation Strategies for all registered and protected NARDI intangible assets.
